INTRODUCTION

1. What are your top three campaign promises or goals, and what action will you take to achieve them if elected?

Promise 1: Building a Safer Community- As a South Bronx resident since 1997 and an NYPD Auxiliary Police Officer for nearly a decade, I recognize the urgency of addressing rising crime. If elected, I am committed to investing in violence intervention and prevention programs while fostering stronger relationships between the community and law enforcement

Promise 2: Affordable Housing and Homeownership for all-I am committed to collaborating with housing organizations and policy experts to make meaningful investments in affordable housing, homeownership and ending our homelessness crisis. We must halt unreasonable rent hikes, build true affordable housing for all, hold landlords accountable for deceptive practices that force constituents out of rent-stabilized units, and invest in programs that create pathways to homeownership.

Promise 3: Empowering our Youth and fighting for a better Educational System- If elected, I am committed to investing and working with educators in the usage of more multi-systemic and evidence based approaches to target our educational crisis.

2. If elected, what is the first piece of legislation you would introduce? Why is that your top priority? If you are an incumbent, please also state what legislation you have passed which you are most proud of.

If elected, the first piece of legislation I would introduce would be a comprehensive Affordable Housing and Rent Stabilization Act. This bill would focus on immediate and long-term solutions to address our housing crisis, including halting unreasonable rent hikes, implementing stronger rent control measures, holding landlords accountable for deceptive practices and expediting rental assistance vouchers for people facing homelessness.

This is my top priority because affordable housing is the foundation of a thriving, stable community. Without it, families struggle to make ends meet, individuals face the risk of displacement, and it affects the socio-economic dynamic of our city.

3. In your view, what are the major needs of your district's constituents?

The major needs of my district's constituents are deeply rooted in the essential aspects of daily life: affordable and low-income housing, public safety, access to quality education, mental health services, economic opportunities, and addressing food insecurity.

4. How long have you lived in the district in which you are running, and do you have any achievements or involvement in your neighborhood you are particularly proud of?

I have proudly resided in my neighborhood since 1997, and as a product of the public education system, I have dedicated my life to grassroots organizing and community service. Currently, I serve as the State Committeeman for the 85th NYS Assembly District, which represents my area. My professional experience spans several roles, including Office Manager for Assemblyman Marcos A. Crespo, Bronx Borough Liaison for former NYC Comptroller Scott M. Stringer, NYPD Auxiliary Police Officer, and my current position as Director of Constituent Services for NYC Comptroller Brad Lander. Every one of these positions has been

deeply connected to my community or directly representing my neighborhood.

Throughout my career, I have had the privilege of achieving many milestones, such as advocating for the implementation of traffic lights, speed bumps, and other essential city services. However, I am most proud of the cohort of young professionals I have mentored since they were children. Today, they are inspired by my work and continue to uplift our community, carrying forward the values of service and leadership that I have dedicated my life to.

5. What experience have you had with good government and reform issues? (e.g., voting and election reform, campaign finance, ethics, police accountability, government transparency). If you've worked to advance these goals, we'd love to hear about it.

Throughout my career, I have played a pivotal role in resolving and assisting constituents with thousands of quality-of-life concerns. As Director of Constituent Services at the Office of the Comptroller, I have worked to advance government transparency and accountability by ensuring our constituents receive the best possible services from City agencies, assisting over 30,000 families annually. In this role, I have also advised the office on various citywide socio-economic issues, which have contributed to the implementation of audits and policy reports.

As a former Auxiliary Police Officer, I worked closely with our coordinator and the community to bridge the gap between policing and the people we serve. I helped coordinate and executed several events, such as The Autism Walk at the 41st Precinct and food distribution for those facing homelessness in our community.

6. What do you think the role of the City Council is in city government this upcoming term?

The role of the City Council in city government during this upcoming term is to serve as a vital check and balance and a guide for many NYC constituents, who currently feel a lack of hope and meaning in government. The Council must ensure that we prioritize passing legislation that addresses the city's most pressing issues, such as public safety, affordable housing, economic development, and education.

We must continue to work collaboratively with community organizations, local stakeholders, and colleagues in other branches of government to craft solutions that are both practical and inclusive. By doing so, we can rebuild trust in government and ensure that policies reflect the needs of all New Yorkers.

ELECTIONS AND VOTING

7. Do you support moving New York City's elections from odd-numbered years to even-numbered years, and will you co-sponsor a Council Resolution supporting that measure?



Voter turnout in New York City elections is exceptionally low, as they are held "off-cycle" in odd-numbered years. To boost local voter turnout and reduce participation gaps, the Legislature passed and Governor Hochul signed a law that moves county and town elections to even-numbered years, and lawmakers are supporting a constitutional amendment that would do the same for city elections, including New York City's. Citizens Union is Leading a coalition of groups advocating to move New York City's elections to even-numbered years, and the City Council is considering a Resolution in support of that shift.

- 8. The New York City Board of Elections (NYC BOE) has been a source of frustration for voters and candidates for years. The City Council appoints NYC BOE members and has the power to appoint commissioners who are committed to reform, but the most recent commissioners have been appointed behind closed doors. Do you commit to request a public hearing for BOE nominees, and to only vote for individuals who are publicly committed to reducing party-based patronage and supporting open hiring

POLICE ACCOUNTABILITY

This approach ensures a fair, informed process while incorporating both internal leadership and independent oversight to maintain accountability and public trust.
