# INTRODUCTION

**1. What are your top three campaign promises or goals, and what action will you take to achieve them if elected?**

Promise 1: Public Safety - fully fund the NYPD

Promise 2: Quality Schools - keep the SHSAT, expand Gifted & Talented Programs

a) Roll back the City of Yes, this has nothing to do with affordable housing, it is merely a blank check to developers telling them to enter any community and build, build, and build. My district's infrastructure is already at capacity and needs to be upgraded to meet existing 1 and 2 family homes; b) Roll back bail reform; c) Stop congestion pricing.

**4. How long have you lived in the district in which you are running, and do you have any achievements or involvement in your neighborhood you are particularly proud of?**

I have lived in Elmhurst since 1976. I protested the opening of the Pan Am shelter, had kitchens installed in the shelter and negotiated the operator to provide social services to the homeless. I also stopped the opening of the Holiday Inn homeless shelter, and protested the shutting down of a Maspeth synagogue and converted into a illegal migrant shelter at taxpayers' expense. As CEC 24 President I worked with the District Superintendent to open the dual language English-Polish program at PS 153. I lobbied in Albany, testified at Senate, Assembly, and City Council hearings to keep the test for Specialized High Schools, bring back the Gifted and Talented Programs, and oppose congestion pricing and the City of YES. I secured funds for in-district nonprofits to clean up the graffiti, hold e-recycle events, and provide vital services to veterans. I have lived in this district most of life, I care about it and I am ready to serve as Councilman on Day 1.

**5. What experience have you had with good government and reform issues? (e.g., voting and election reform, campaign finance, ethics, police accountability, government transparency). If you've worked to advance these goals, we'd love to hear about it.**

Need voter ID to reduce voter fraud, the CCRB is an outdated agency and needs to be reformed. There is a lot of fraud in the public assistance system and it needs a top down overhaul. City Council needs to have more oversight on the Mayor's Office for corruption. This is common sense, no experience needed.

**6. What do you think the role of the City Council is in city government this upcoming term?**

City Council needs to have oversight to address corruption in the Executive Branch of the City. City Council also needs to make sure there is no corruption within itself. Laws needs to be passed to prevent special interests groups from having excessive influence on City policy. There needs to be stronger oversight on nonprofits getting city funding.

# ELECTIONS AND VOTING

Voter turnout in New York City elections is exceptionally low, as they are held “off-cycle” in odd-numbered years. To boost local voter turnout and reduce participation gaps, the Legislature passed and Governor Hochul signed a law that moves county and town elections to even-numbered years, and lawmakers are supporting a constitutional amendment that would do the same for city elections, including New York City’s. Citizens Union is [leading a coalition of groups advocating](#) to move New York City’s elections to even-numbered years, and the City Council is considering a [Resolution in support](#) of that shift.
