INTRODUCTION

1. What are your top three campaign promises or goals, and what action will you take to achieve them if elected?

Promise 1: I launched my campaign with a bold plan, Rebuild NYC, which is a mandate for one million new homes - my campaign's top priority. Housing is the foundation for fixing many of our city's challenges. With costs soaring, New Yorkers are struggling to afford their rents, let alone consider purchasing a home in the neighborhoods where we grew up. People are leaving the city because staying has become financially untenable. By increasing housing supply, we can bring down costs for everyone and ensure that our city continues to grow. The choice is clear: either we build more, or we lose New Yorkers.

Promise 2: Affordability extends far beyond the housing crisis. The cost of living in New York City has become unsustainable, especially for families. One key element of my overall affordability plan is creating free, universal afterschool. These programs will not only provide students with opportunities to continue learning and remain safe after school hours—when violent crime is most likely to occur—but also offer immense relief to working families facing skyrocketing childcare costs. Implementing Afterschool for All would ease the financial burden of raising a family and help ensure that New York remains a place where families can thrive.

Promise 3: One of the fundamental responsibilities of government is to keep its citizens safe. Despite Eric Adams' promises, violent crime is still well above pre-pandemic levels, and many New Yorkers feel more unsafe today than they have in years. Whether on the subways or in the streets, the public's concern is clear. As mayor, my major public safety priorities will include boosting clearance rates with a focus on solving shootings as well as ensuring New Yorkers can safely commute and feel safe wherever they are in our city.

2. What experience have you had with good government and reform issues? (e.g., voting and election reform, campaign finance, ethics, police accountability, government transparency). If you've worked to advance these goals, we'd love to hear about it.

I have worked diligently to promote good governance and advance reforms that improve the lives of New Yorkers.

As the former Chair of the NYS State Senate's Elections Committee, I led the fight to establish early voting, close the LLC loophole that corrupted our campaign finance system, and simplified the absentee ballot process for voters during a once-in-a-century pandemic. I am especially proud to have authored the landmark John R. Lewis Voting Rights Act of NY – the strongest voting rights law of any state in the country. This law has already been used to expand voting rights for underrepresented groups, and will be instrumental in fighting back against the forces seeking to diminish our democracy in the years ahead.

I have also led efforts to improve transparency in procurement, by sponsoring legislation to restrict campaign contributions from vendors seeking state contracts. By eliminating opportunities for corporate influence in government contracting, we can protect taxpayer dollars from special interests and ensure that public officials remain accountable.

I have also fought to protect New Yorkers from deceptive business practices by championing legislation that increases penalties for consumer frauds, holds corporations accountable for predatory marketing that targets young people, and requires transparency in the pharmaceutical supply chain that threatens the affordability of lifesaving prescriptions.

At the core of my public service is a commitment to transparency and accountability. As Mayor, I look forward to creating a fairer, more transparent, and more accessible government that prioritizes the needs of all New Yorkers.

ELECTIONS AND VOTING

3. Do you support moving New York City's elections from odd-numbered years to even-numbered years, and will you publicly support efforts in Albany to implement this reform?



Voter turnout in New York City elections is exceptionally low, as they are held "off-cycle" in odd-numbered years. To boost local voter turnout and reduce participation gaps, the Legislature passed, and Governor Hochul signed, a law that moves county and town elections to even-numbered years, and lawmakers are supporting a constitutional amendment that would do the same for city elections, including New York City's. Citizens Union is Leading a coalition of groups advocating to move New York City's elections to even-numbered years, and the City Council is considering a resolution in support of that shift.

4. The New York City Board of Elections (NYC BOE) has been a source of frustration for voters and candidates for years. How will you use your power as Mayor to improve the operations of the NYC BOE and ensure that its operations are transparent and accountable to the public?

In 2021, I held a series of hearings on election administration across the State, and issued a landmark report on reforming elections and improving the voter experience. This report laid out a series of systemic and institutional challenges facing the New York City Board of Elections and voters in NYC. My report included more than 50 recommendations to restructure boards of elections and improve and protect voting rights. I'm proud that Citizens Union strongly embraced the report, urging the Legislature to adopt its recommendations.

As Mayor, I will do everything within my power to expand and protect voting rights and ensure our elections are fair, transparent and accountable. That means building on the work of Democracy NYC (before it was weakened by the current mayor) to support robust voter registration efforts (especially to young people), expand city-funded translators at poll sites above and beyond what is required by State and Federal law, and do more to ensure sufficient early-voting poll sites. I will also continue to advocate for state legislation that would restructure the NYC Board of Elections.

Since I joined the State Senate in 2019, I have diligently worked to expand voting rights, improve our elections and defend our democracy. As chair of the Elections Committee, I've held hearings with voters across the state and issued a report highlighting dozens of ideas to make our voting process easier and fairer for all New Yorkers.

I sponsored the John R. Lewis Voting Rights of New York Act, which expanded language assistance for voters and provided new legal tools to fight discriminatory voting provisions in court.

It also ensured that a preclearance program is in place, requiring that local governments with records of discrimination get approval from the state attorney general's office if they wanted to make any changes to their systems of voting.

I also sponsored the Dr. John L. Flateau Voting and Elections Database and Academic Center of New York Act, which established the New York voting and elections database and instituted a statewide database of voting and election data, which was not previously centralized.

Furthermore, I've championed legislation that would allow snacks and non-alcoholic drinks to be given to voters waiting in line at the polls, expanded party position eligibility to include non-binary individuals, and called for higher wages for election day workers in New York City.

POLICE ACCOUNTABILITY

New Yorkers deserve a police department that is accountable to the public. Public safety is dependent on communities trusting law enforcement. Under my leadership, New York City will take significant steps to ensure that both the NYPD as a whole and individual officers are held accountable to the public.

As a part of my Rebuild NYC public safety plan, I will fund the CCRB at 1% of the NYPD's overall budget, bringing the CCRB's funding in line with other cities' civilian oversight agencies. I'll also offer CCRB direct access to NYPD investigatory material to speed investigations. Lastly, I will dismiss police officers with repeated and/or severe substantiated claims of misconduct, and improve diversity within the NYPD's top leadership to build trust with communities.

13. How do you view the role of the Deputy Mayor for Public Safety?

As Mayor, I will conduct a review of deputy mayor offices to ensure they have a clear scope and that each role is structured to deliver the best results for all New Yorkers. My priority is to appoint the most qualified professionals with proven effectiveness and the highest ethical standards and empower them to do their jobs.

My plan to Rebuild Public Safety and the Public Square is built on the essential premise that a well-managed, fully accountable police department is vital to fighting crime and ensuring safety for all New Yorkers. The plan also emphasizes the urgent need to address the mental health crisis that impacts many New Yorkers on our streets and subways, and ensuring fairness and reducing recidivism through criminal justice reform.

My five-part plan includes

Clear 100, which aims to reverse the decline in the number of NYPD detectives to solve more shootings and reduce gun violence;

Restaffing the NYPD to return to 2018 staffing levels to enhance the department's capacity to prevent crime;

Safe Streets, Safe Subways, an initiative to prioritize safety and order throughout the transit system and on our streets by deterring antisocial behavior and responding swiftly before situations escalate; Restoring Accountability, which implements a rigorous oversight system to curb excessive NYPD overtime, eliminate abuse, and protect taxpayers; and,

Crime Prevention, a focus on smart community investments and addressing the root causes of crime. All New Yorkers deserve to feel safe in their city, but too many are experiencing a growing sense of insecurity due to rising public safety concerns. As Mayor, I will ensure that holistic public safety is one of the most important responsibilities of my administration.
